
Animas River Days! **RETAIL & NON-PROFIT VENDOR APPLICATION**

Application Deadline: Wednesday, May 15th, 2024

All applications will be reviewed and someone from the Animas River Days planning committee will contact you if you are accepted as a vendor. Booths are available by reservation only. Be sure to reserve your booth early as there is limited space at the park.

Please read all restrictions and requirements before submitting vendor application. If for some reason you reserve a booth and find you cannot attend Animas River Days, you must notify us before May 20th, or we will keep a \$50 administration fee.

RESTRICTIONS AND REQUIREMENTS:

(All vendors and anyone having a booth at Animas River Days)

- Vendors must submit vendor application form, payment, and necessary documentation before the vendor application deadline: <u>May 15, 2024</u>. All vendor applications are subject to approval by Animas River Days' planning committee.
- 2. We aspire to be a 100% Zero Waste event. Please do your best to reduce the amount of trash that goes to the landfills and focus on using sustainable products that can be composted, reused and recycled.
- 3. The City of Durango will give instructions for set-up and break-down. <u>Be prepared to be in the park for set up as early as 6am on Saturday, June 1st</u> (this will be determined by the City of Durango). You will be sent instructions for set-up and break-down the week before the festival so please check your emails regularly during that time.
- 4. Vendors must breakdown, pack-up and leave the festival ground according to the City of Durango's instructions. The festival will be completed at approximately 8pm on Saturday, June 3rd. There MAY be an opportunity to pack up and leave late afternoon before the parade, but this is completely dependent on the City's guidelines, and parade time is the busiest time of event day.
- 5. Vendor parking will be available in the general Santa Rita Park parking area.
- 6. Vendors must be prepared for rain, snow, or shine (easy-up tents are recommended).
- 7. Vendors must abide by City of Durango's restrictions including:
 - a. Weighting of each tent or canopy is required: 10x10 = 40 lbs. weight; larger than 10x10 = 80 lbs. weight, attached to each corner of the tent or canopy. Structures shall be adequately roped, braced, and anchored to withstand the elements of weather and prevent collapse.
 - b. Fire break of 12' between tents and from buildings/combustibles.
 - c. No smoking under the tent or canopy.
 - d. No open flame under tent or canopy. Portable heaters are restricted.
 - e. Hay, straw, shavings, and similar combustible materials are prohibited.
 - f. Fire extinguishers within 75' minimum. Fire extinguisher in conspicuous location, unobstructed and secured with a sign.
- Vendors must pay sales tax to the state of Colorado to benefit the City of Durango; You
 must contact the City of Durango City Clerk for sales tax licensing (970-375-5010).
 Appropriate paperwork must be submitted with vending application.
